4.1. Description of first aid measures

General advice	If symptoms persist, call a physician.

Suitable extinguishing media

Do not let product enter drains.

Cover spillage with suitable absorbent material. Using non-spark tools, sweep up material and place in an appropriate container. Decontaminate spill site with 10% caustic solution and ventilate area until disposal is complete. Hold all material for appropriate disposal as described under section 13 of SDS.

7. HANDLING AND STORAGE

- 7.1. **Precautions for safe handling**
Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.
- 7.2. **Conditions for safe storage, including any incompatibilities.**
Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Recommended storage temperature: Store at RT (desiccate)
