4. FIRST AID MEASURES

4.1.

Description of first aid meas General advice	ures If symptoms persist, call a physician.
Eye contact	Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Call a physician immediately.
Skin Contact	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Call a physician immediately.
Ingestion	Rinse mouth. Do not induce vomiting without medical advice. Never give anything by mouth to an unconscious person. Call a physician or poison centre immediately.
Inhalation	Move to fresh air. Avoid direct contact with skin. Use barrier to give mouth to mouth resuscitation. Call a physician or poison centre immediately.

- **4.2. Most important symptoms and effects, both acute and delayed** Exposure may cause the following: Lip tingling sensation, numbness, weakness, convulsions or seizure. Exposure may be fatal if allowed to enter the blood stream. Death can occur within 30 minutes of exposure.

5. FIRE-FIGHTING MEASURES

- 5.1. Extinguishing media Suitable extinguishing media Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide
- 5.2. Special hazards arising from the substance or mixture In combustion, may emit toxic fumes.
- **5.3. Precautions for fire-fighters** Wear suitable protective clothing to prevent contact with skin and eyes and selfcontained breathing apparatus.

6. ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures Do not take action without suitable protective clothing – see section 8 of SDS. Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid breathing vapours, mist, dust or gas.

6.2. Environmental precautions

Do not let product enter drains.

6.3. Methods and materials for containment and cleaning up

Cover spillage with suitable absorbent material. Using non-spark tools, sweep up material and place in an appropriate container. Decontaminate spill site with 10% caustic solution and ventilate area until disposal is complete. Hold all material for appropriate disposal as described under section 13 of SDS.

7.1. Precautions for safe handling

Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

7.2. Conditions for safe storage, including any incompatibilities.

Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Recommended storage temperature: Store at -20°C

Use in a laboratory fume hood where possible. Refer to employer's COSHH risk assessment.
