## 4. FIRST AID MEASURES

### 4.1. Description of first aid measures

**General advice** If symptoms persist, call a physician.

**Eye contact** Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. If symptoms persist, call a physician.

Decontaminate spill site with 10% caustic solution and ventilate area until disposal is complete. Hold all material for appropriate disposal as described under section 13 of SDS.

## 7. HANDLING AND STORAGE

**7.1. Precautions for safe handling**  
Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

**7.2. Conditions for safe storage, including any incompatibilities.**  
Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Recommended storage temperature: Store at -20°C (desiccate)

Use in a laboratory fume hood where possible. Refer to employer's COSHH risk assessment.
